

GENERAL REGULATIONS:

- Article 1: The driving of the Karts will have to be done correctly. The activity may end, in the event that this rule is not complied with, losing the total amount without the right to claim if any of these causes pass:
 - 1. To get out of the track.
 - 2. To overcome the barriers of protection.
 - 3. To close or not give way.
 - 4. To push some vehicle in circulation.
 - 5. To ignore the signals of karting staff.
 - 6. To drive dangerously.
 - 7. To stay in the Boxes (dangerous area) or for other justified reasons that the person in charge of the court considers.
- Article 2: It is strictly forbidden to stay in the boxes area.

Once you have purchased your ticket, you will have to wait for your turn behind the protective fence. People who do not comply with this rule will be responsible for any damage they may suffer or cause to infringe the regulations.

It is only possible to enter or leave the box area, when karting personnel indicate it. If you do not take into account the indications of the track staff, you may lose the right to carry out the activity and the amount of the ticket.

Remember, for your safety: DON'T STAY IN THE BOXES AREA!

- Article 3: Smoking is forbidden in the boxes area and when karts are rolling on the track.
- Article 4: In the event that a driver causes an accident, the driver must be responsible for damages caused to the vehicle and/or to third parties.
- Article 5: The use of the helmet during driving is mandatory. This will be delivered by the karting staff before the start of the activity. However, the user must wear a suitable clothing for the activity.
- Article 6: It is forbidden to throw objects such as: footwear, glasses, clothes, helmet... from the kart.
- Article 7: In the event of a failure or an incidence with kart, if it is stopped on the track it does not come down from the kart because it is very dangerous. What you have to do in this case is raise your hands and wait to be cared for by karting staff.
- Article 8: MOVIDAS VARIAS SL, takes care that karts are in the optimal conditions to be used. However, if you consider that your vehicle is not in the best condition to carry out the activity, stop in boxes once you have done the first lap. Do not wait at the end of the activity to make the claim, since then it will be impossible to offer you some type of compensation, since you will have consumed the contracted activity.
- Article 9: This company may cancel any ticket (returning the amount before going up to the kart) if it thinks it necessary, for any justified cause: state of intoxication, not having the legal age or height...
- Article 10: The company reserves the right to sell the tickets outside the scheduled time due to weather, deficiencies in the lighting of the track or due to force majeure. Tickets sold will be paid or the activity will be postponed for another day.
- Article 11: The ticket price is for person and kart. It will not be possible to distribute the laps or the total time of the activity between different users.



- Article 12: The driving of the karts will have to be correct, giving way to the runners who want to make an advance.

 Advances must be made as long as safety is not jeopardised, in order to avoid accidents.
- Article 13: You cannot drive a kart without the approved and properly insured helmet. People with long hair must wear it in their helmet.
- Article 14: During the activity on the track, no part of the body can leave the kart.
- Article 15: You cannot drive a kart without footwear or without the right footwear.
- Article 16: You can't get into the kart with clothes hanging like: scarves,...
- Article 17: MOVIDAS VARIAS SL is not responsible for the objects that may be lost during the kart driving and that have not been previously deposited at the box office. This regulation has been approved by MOVIDAS VARIAS SL. At all times, we want to ensure the safety of our customers. For any claim, we ask you to contact the director of karting, who will gladly attend to him.

FOR THE SAFETY OF THE DRIVER

- Wear appropriate clothing, without any free garments (clothes, scarves...)
- Well fixed and covered footwear, without risk of trapping
- Make sure you have the safety helmet well set
- Do not carry objects that may fall during driving
- Leave the pit area as quickly as possible
- Always stay inside kart, raise your hands in case of stop or accident avoid any type of accident on the track

RESPONSABILITIES:

- The circuit will not be responsible for damage to personal belongings or damage to clothing due to weather conditions or substances from the kart.

REASONS FOR EXPULSION

- Dangerous, negligent or anti-sports driving
- -Dressing or pushing other karts or track limits
- Repeatedly overcome protections due to lack of control
- Close and not give way to other karts
- -Circulate in the opposite direction
- -Produce damage in karts or facilities
- -Participate under the effects of alcohol or banned substances
- -Use mobile devices during driving
- -Don't follow trackhead or initial instructions

IN CASE OF NOT COMPLYING WITH THE FOLLOWING RULES, THE HEAD OF THE TRACK WILL PROCEED TO THE EXPULSION OF THE PARTICIPANT WITHOUT ANY TYPE OF SUBSCRIPTION



GROUP REGULATIONS

<u>The group booking</u> will be made through the corresponding contract and must be confirmed with a €50 deposit. All members of the group must present their ID on the day of the event. If no booking is made, Karting Cross Empuriabrava will assign the group a time slot based on track availability at the time.

The group may only be postponed in the event of a justifiable force majeure, so the deposit amount will not be lost. Otherwise, this amount will be used to cover the company's expenses.

Each group will have the option to pay an additional €5 so that, in case the activity cannot take place due to weather conditions, the deposit can be refunded. Otherwise, the activity can only be rescheduled.

<u>The payment</u> of the rest of the amount will be made in **CASH**, before starting the rented time, so the organizer must be on the circuit 30 minutes before the agreed time for the first round, having to start the group at the agreed time. ANY DELAY BY THE GROUP WILL AFFECT THE PLANNED SCHEDULE, THUS LOSING ITS AGREED TIME.

<u>The organizer of the group</u> will be for all purposes the responsible of the people who are part of the groups (who must be over 18 years old and in case they are minors, having the necessary height, they must present an authorization of the father or tutor signed) and who participate in any aspect, as well as being responsible for the use that these people make of the rented karts, the material and the facilities.

In the event that the pilots wanted to use their helmet, it must be integral, as well as it is recommended to use the appropriate clothing, avoiding if it is possible to run in short sleeves, shorts and sandals.

<u>The general regulations</u> will be applied using the same criteria as a standard session. Therefore, if the track manager deems it necessary, based on track regulations and in the best interest of the participants, they may remove a participant from the track without the possibility of return or ticket refund.

Each group must pay a €100 deposit in cash on the day of the activity. This deposit covers any potential damage caused to the karting equipment by any member of the group during the activity.

The deposit will be fully refunded after the activity, provided that:

- No damage has occurred to the karts or equipment (helmets, protective gear, etc.).
- All participants have complied with safety regulations and the instructions of the track staff.
- No behavior has been observed that endangers other participants or the operation of the facilities.
- In the event of any damage, the cost of repair will be deducted from the deposit. If the cost of the damage exceeds the deposit, the group will be responsible for the difference, as determined by the karting staff's technical assessment.
